A Law to Amend the Towns and Communities Law.

Enacted by the Legislature of the Cayman Islands.

1. This Law may be cited as the Towns and Communities (Amendment) Law, 1966 and shall come into operation on a day to be appointed by the Administrator by Government Notice published in the Cayman Islands.

2. Section 3 of the Towns and Communities Law (hereinafter referred to as the principal law) is hereby amended by substituting the words "six pounds" for the words "forty shillings" where they occur in the last line thereof.

- Amendment of section 5. 3. Section 5 of the principal law is hereby amended by substituting the words "six pounds" for the words "forty shillings" where they occur in the last line thereof.
- Amendment of section 6. 4. Section 6 of the principal law is hereby amended by substituting the words "nine pounds" for the words "sixty shillings" where they occur in the fourth line thereof.
- Amendment of section 8. 5. Section 8 of the principal law is hereby amended by substituting the words "six pounds" for the words "forty shillings" where they occur in the fifth line thereof.
- Amendment of section 9. 6. Section 9 of the principal law is hereby amended by substituting the words "nine pounds; or to imprisonment for a period not exceeding thirty days" for the words "sixty shillings; or to imprisonment with or without hard labour for a period not exceeding thirty days" where they occur in the third, fourth and fifth lines thereof.
- Amendment of section 11. 7. Section 11 of the principal law is hereby amended —
(a) by substituting the words "six pounds" for the words "forty shillings" where they occur in the seventh line thereof; and
(b) by deleting the words "with or without hard labour" where they occur in the ninth and tenth lines thereof.
- Amendment of section 12. 8. Section 12 of the principal law is hereby amended —
(a) by substituting the words "six pounds" for the words "forty shillings" where they occur in the tenth and eleventh lines of subsection (1) thereof; and
(b) by substituting the words "six pounds" for the words "forty shillings" where they occur in the tenth line of subsection (2) thereof.
- Amendment of section 13. 9. Section 13 of the principal law is hereby amended by substituting the words "fifteen pounds" for the words "five pounds" where they occur in the last line thereof.

- Amendment of section 14. 10. Section 14 of the principal law is hereby amended by substituting the words "six pounds" for the words "forty shillings" where they occur in the last line thereof.
- Amendment of section 15. 11. Section 15 of the principal law is hereby amended by substituting the words "fifteen pounds" for the words "five pounds" where they occur in the last line thereof.
- Amendment of section 20. 12. Section 20 of the principal law is hereby amended by deleting the words "with or without hard labour" where they occur in the eleventh and twelfth lines thereof.
- Amendment of section 21. 13. Section 21 of the principal law is hereby amended by deleting the words "with hard labour" where they occur in the ninth line thereof.
- Amendment of section 25. 14. Section 25 of the principal law is hereby amended by substituting the words "thirty pounds" for the words "ten pounds" where they occur in the sixth line thereof.
- Amendment of section 26. 15. Section 26 of the principal law is hereby amended by substituting the words "fifteen pounds" for the words "five pounds" where they occur in the fifth line thereof.
- Amendment of section 28. 16. Section 28 of the principal law is hereby amended by deleting the words "with or without hard labour" where they occur in the seventeenth line thereof.
