### THE OFFICIAL GAZETTE LAW

Offences.

- 11. It is an offence under this Law -
  - (a) to procure or attempt to procure the publication of any unauthorized matter in the Gazette;
  - (b) wilfully to cause to be published in the Gazette any false or inaccurate matter; or
  - to contravene any rule, order or regulation made under this Law.

Regulations.

- 12. The Governor may make rules, orders and regulations prescribing -
  - (a) for the printing, production and circulation of the Gazette;
  - (b) scales of fees to be charged for publication of items in the Gazette; and
  - anything permitted or required to be prescribed by this Law.

General penalty. 13. Any person who contravenes any provision of this Law or any rule, regulation or order made thereunder is guilty of an offence and liable on summary conviction to a fine not exceeding \$500 or to imprisonment for a term not exceeding six months or to both such fine and such imprisonment.

Savings.

14. Every publication made prior to the coming into effect of this Law purporting to be a publication of matter which would have been required or authorised to be published in the Gazette, if this Law had been enacted before the date of such publication shall, for the purposes of this Law, be deemed to be a publication in the Gazette.

# A LAW TO ESTABLISH AN OFFICIAL GAZETTE FOR THE CAYMAN ISLANDS

Law No. 26 of 1974

ENACTED by the Legislature of the Cayman Islands.

Short title and commencement.

1. This Law may be cited as the Official Gazette Law and shall come into effect on a day to be appointed by the Governor by Government Notice published in the Cayman Islands.

Interpretation.

2. In this Law -

"Governor" means the Governor in Council.

Establishment of the Gazette.

3. There is hereby established a publication called the Cayman Gazette hereinafter called "the Gazette".

Application to other Laws.

4. Every reference in any Law to the Gazette, the Official Gazette, the Cayman Gazette or similar title is a reference to the Gazette hereby established.

Publication etc.

5. The Gazette shall be printed and circulated by order of and, in so far as specific directions are not provided by this Law, under the direction of the Governor.

Form of the Gazette.

6. The Gazette shall be published fortnightly on alternate Mondays on and with effect from the 6th day of January,

1975 and upon such other occasions as may be ordered by the Governor and shall contain inter alia -

- (a) the title and the date of publication;
- (b) a list of official Gazette supplements published concurrently therewith under the provisions of section 7:
- such official advertisements and notices as are required or authorised by any Law to be published in the Gazette or as Government or Public Notices;
- (d) such advertisements and notices by private members of the public as may be authorised generally or specifically or by the Governor by regulation or otherwise; and
- (e) any other matter directed to be published in the Gazette by the Governor.

Supplements.

- 7. There shall be published contemporaneously with each Gazette in supplementary form -
  - (a) all Bills to be presented to the Legislature;
  - (b) all enactments of the Legislature;
  - (c) All Statutory Rules and Orders; and
  - (d) such Regulations, Rules and other supplementary matters as may be required or authorised by the Governor to be published.

Effect of publication.


8. A printed copy of a Gazette or of a Gazette Supplement purporting to be issued under the authority of this Law shall be received as prima facie evidence of its contents and of its authenticity both with judicature and thereout.

Circulation.

9. The Gazette shall be offered for sale to the public at such price per copy at such places and times as the Governor may by regulation direct.

Protection of the word "Gazette".

10. It is an offence to use the word "Gazette" in association with the word "Cayman" in any publication otherwise than by way of **bona fide** reference to the Gazette established by this Law.

8. The charge to the public for announcements in the Gazette otherwise than under the Patents and Trade Marks Law (1995 Revision) is ten dollars per single column/inch.

# Fees for patents and trade marks

- 9. (1) The charges for publication in the Gazette of the recording of the extension of a United Kingdom patent and trade mark right to the Islands are prescribed in the First Schedule.
- (2) The charge for publication under subregulation (1) includes publication preceded by the general heading, for which no charge is raised, set out in the Second Schedule.

# Patent and trade mark extensions

10. Applicants for recording of the extension of United Kingdom patents and trade marks are required to remit the publication fee to the Registrar of Patents and Trade Marks, Grand Cayman, Cayman Islands, B.W.I. with their applications.

### Page and print size

11. The type area of a page is 7 1/2" in height x 5 3/4" across. Printing is in 8.5 point type unless some other type is requested. Trade mark words will be printed in 12 point type or as otherwise requested. Two accurate reproductions of each mark must accompany each application. Blocks are not required.

#### Free copies

12. One copy of the relevant Gazette in respect of each patent or trade mark publication will be sent post free by air mail to the proprietor or first-named proprietor of the recorded right, or to his named agent.

# OFFICIAL GAZETTE REGULATIONS

# (1995 Revision)

### General

1. These Regulations may be cited as the Official Gazette Regulations (1995 Citation Revision).

2. In these Regulations-

Definitions

"editor" means the editor of the Gazette;

"Gazette" means the Cayman Gazette established by section 3;

"Law" means the Official Gazette Law;

Law 26 of 1974

"printer" means the person appointed by the Governor to print the Gazette; and

"section" means a section of the Law.

3. The Gazette shall be edited by a public officer as defined in the Public Editor Service Commission Law (1995 Revision) appointed by the Governor from time 1995 Revision to time by Notice published in the Gazette.

4. The Gazette shall be printed by a person appointed by the Governor from Printer time to time by Notice published in the Gazette.

Free circulation

5. There shall be a free circulation of the Gazette and all Supplements thereto, at such times as the Governor, acting in his discretion, may, from time to time. determine.

Price of Gazette

6. Copies of the Gazette and of Supplements may be obtained from the printer by members of the public on payment of \$1.30 for each Gazette and 52 cents for each Supplement plus 20 cents for every page by which such Supplement exceeds four pages.

7. Gazettes and Supplements may be subscribed for by members of the public Annual subscription annually beginning on the 1st day of January in any year, or pro rata, on payment of twenty-six dollars in respect of Gazettes and one hundred and ninety-five
