THE TRAVEL TAX REGULATIONS

THE TRAVEL TAX LAW, 1976  
(Law 11 of 1976)

TRAVEL TAX REGULATIONS

In exercise of the powers conferred upon the Governor in Council by section 6 of the above Law the following Regulations are hereby made.

- 1. These Regulations may be cited as the Travel Tax Regulations.
- 2. In these Regulations —

“Law” means the Travel Tax Law, 1976;

“section” means a section of the Law; and section 2 applies.

- 3. Every agent collecting money from a traveller or tourist under section 4 shall furnish to such person individually or collectively an appropriate receipt in the form prescribed in the Schedule.
- 4. Every agent shall on or before the 10th day of each month account to the Collector for all sums collected in the previous month in the form prescribed in the Schedule providing the details for which provisions is made therein paying the cash shown as having been so collected or a cheque drawn in favour of the Collector for the said amount.
