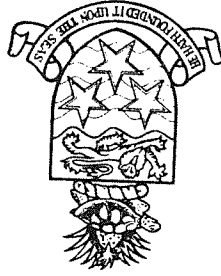

[No. 16 of 1973]

TRAFFIC [AMENDMENT] [NO. 6] REGULATIONS, 1978

In exercise of the powers conferred upon the Governor in Council by sections 51(1), 62(2), 77(b) and 82 of the Traffic Law, the following Regulations are hereby made.

1. These Regulations may be cited as the Traffic (Amendment) (No. 6) Regulations, 1978.

Traffic Regulations, 1973, amended.

2. The Traffic Regulations, 1973, are hereby amended as follows -
A. in regulation 11 by inserting between the words "of" and "subsection" appearing therein the words "subsection (3) of section 42 and";
B. by deleting regulation 13 and replacing it with a new regulation as follows -

13. The prescribed uniform for school crossing patrols is a white dust coat or mackintosh with or without fluorescent jacket, sleeves or armbands;

C. in regulation 25 by the addition of a new sub-regulation thereto as follows -
"(3) Any device applied to the windscreen or any window of any road vehicle whereby the transparency thereof in either direction is diminished is hereby declared to be unsafe for the purpose of sub-regulation (1) (a) unless it is part of the maker's standard equipment or is specifically approved by the Governor"; and

D. in regulation 27 by the addition of a new item to follow 43(1) as follows -
"51 - Truck driver's licence including special vehicles \$5.00."
