(AMENDMENT) REGULATIONS 1994

The Governor in Council, after consultation with the Water Authority and in exercise of the powers conferred on him by section 60 of the Water Authority Law 1982 **(a)**, makes the following Regulations: –

Citation and commencement.

1. These Regulations may be cited as the Water Authority (Amendment) Regulations 1994 and shall come into force on 21st March 1994.

Amendment of the Water Authority Regulations, 1988.

2. The Water Authority Regulations, 1988 **(b)**, are amended as specified in the Schedule.

SCHEDULE

Regulation 2

AMENDMENTS TO THE WATER AUTHORITY REGULATIONS, 1988

1. In regulation 2(1) the words "West Bay Beach Sewerage Scheme (being a public sewerage system)" are revoked and the following words substituted "public sewerage system".
2. In regulation 5(1) the words "West Bay Sewerage Scheme" are revoked and the following words substituted "public sewerage system".
3. In regulation 6(1) the words "George Town Water supply Scheme (being a public water supply system)" are revoked and the following words substituted "public water supply system".
4. In regulations 7(1) and 8 the words "George Town Water Supply Scheme" are revoked and the following words substituted "public water supply system".
5. (1) Paragraphs (1) and (2) of regulation 9 are revoked and the following paragraphs substituted:

"(1) A person who enters into an agreement with the Authority for the connection of premises to the public sewerage system or the public water supply system shall pay a deposit in respect of each connection to be made under the agreement.

(2) The deposit referred to in paragraph (1) –

 - (a) in respect of a connection to the public sewerage system, shall be an amount equal to the monthly charge calculated in respect of the premises under regulation 2;
 - (b) in respect of a connection to the public water supply system, shall be an amount calculated in accordance with paragraphs (2A) and (2B);".
6. The following paragraphs are inserted after paragraph (2) of regulation 9 –

"(2A) Agreement for the connection of domestic premises entered into by or on behalf of:

 - (a) the owner of the premises who intends to occupy them throughout the currency of the agreement, a deposit shall be paid of \$50;
 - (b) a person possessing Caymanian status who does not own the premises, a deposit shall be paid of \$100;
 - (c) a person not possessing Caymanian status who does not own the premises, a deposit shall be paid of \$200.

Notes

1. "owner" means the person who is registered as the proprietor of the parcel or lease which relates to the premises to be connected.
2. "Caymanian status" has the same meaning as in the Immigration Law.

(2C) A deposit paid under this regulation may be refunded by the Authority if the Authority has received –

 - (a) notice that the service provided by the Authority under the agreement in respect of which the deposit was paid is not being used and is no longer required, and
 - (b) all charges payable to the Authority under or in relation to that agreement."
7. In paragraph (3) of regulation 9 –
 - (a) the words "and any accrued interest thereon" are revoked; and
 - (b) the words "West Bay Beach Sewerage Scheme" are revoked and the following words substituted "public sewerage system."
