THE WATER AUTHORITY LAW 1982

THE WATER AUTHORITY (AMENDMENT) REGULATIONS 1995

The Governor in Council, after consultation with the Water Authority and in exercise of the powers conferred on him by section 60 of the Water Authority Law, 1982, makes the following Regulations –

Title and commencement

1. These Regulations may be cited as the Water Authority (Amendment) Regulations 1995 and shall come into force on 1st March 1995.

Amendment of the Water Authority Regulations 1988

2. (1) The Water Authority Regulations, 1988 ("the principal Regulations") are amended as specified in the remaining paragraphs of this regulation.

(2) Paragraph (1) of regulation 2 of the principal Regulations is revoked and the following paragraph substituted –

"(1) The charges to be paid to the Authority for the collection, treatment and disposal of sewage via the public sewerage system are \$1.48 per Sewage Fixture Unit per month on each premises connected to the system."

(3) Regulation 3 of the principal Regulations is revoked and the following regulation substituted –

"Septage charges.

3. (1) The charge to be paid to the Authority for the receipt of sewage at the sewage treatment works from a cesspool emptier is \$15.90 for each 1,000 gallons or part of 1,000 gallons of septage.

(2) In paragraph (1) of this regulation "cesspool emptier" includes any person, whether or not licensed under the Water Authority Law as a cesspool emptier, from whom the Authority

receives sewage at the sewage treatment works in the course of that person's business."

(4) Paragraph (1) of regulation 6 of the principal Regulations is revoked and the following paragraph substituted –

"(1) The charges to be paid to the Authority for the supply of desalinated water via the public water supply system are a monthly charge in accordance with the following categories of consumer or user –

| (a) Domestic | \$4.01 per cubic metre for the first twelve cubic metres and \$4.81 for each cubic metre thereafter, subject to a minimum charge of \$16.04; |
| (b) Truckers | \$4.01 per cubic metre; |
| (c) Water Company | \$4.81 per cubic metre; |
| (d) Commercial and Industrial | \$4.81 per cubic metre, subject to a minimum charge of \$19.24; |
| (e) Municipal (Public Authority) | \$4.35 per cubic metre, subject to a minimum charge of \$17.40; |
| (f) Water sold in Cayman Brac to all categories of users through the piped water distribution system | \$5.60 per cubic metre, subject to a minimum charge of \$22.40; |
| (g) Water sold in Cayman Brac by truck | \$7.00 per cubic metre." |

(5) Regulation 10 of the principal Regulations is amended by revoking the words "two dollars and twelve cents per cubic metre" and substituting "\$2.33 per cubic metre."

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Water Authority Regulations, 1988, to implement increased charges for sewage collection, treatment and disposal and for the supply of water by the Water Authority.
