Citation

1. These regulations may be cited as the Petroleum Handling and Transportation (Licensing) Regulations (1999 Revision).

Forms

2. The form of application for a licence under these regulations and the form of licence are prescribed in the Schedule hereto.

Terms of licenses

3. The acceptance of a licence under these regulations operates as a binding obligation upon the licensee to the Government to comply with all the terms of the Law and all regulations made thereunder having application to the business of the licensee and such obligation operates independently of any penal clauses contained in the Law and regulations.
