## A LAW TO MAKE FURTHER PROVISION IN RESPECT OF THE CHARGING OF FEES UNDER THE PUBLIC HEALTH LAW (1996 REVISION)

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Public Health (Amendment) Law, 2001.

Short title

2. The Public Health Law (1996 Revision), in this Law referred to as the "principal Law", is amended in Part IX by inserting, after section 48, the following section -

Insertion of section 48A in the Public Health Law (1996 Revision) regulations re rodent control

"Regulations re rodent control

48A. The Governor may make regulations -

- (a) for the control and destruction of rats and mice; and
- (b) prescribing fees for any service provided under this Part.".
- 3. The principal Law is amended in section 55 by inserting, after paragraph (c), the following paragraph -

Amendment of section 55 - regulations re cemeteries and crematoria

"(ca) prescribing fees for any service provided under this Part;".

4. The principal Law is amended by inserting, after Part XII, the following Part -

Insertion of Part XIIA special waste handling fees

### "Part XIIA - Special Waste Handling Fees

Special waste handling fees

55A. (1) There shall be charged, collected and paid through Customs -

- (a) a special waste handling fee of two hundred and fifty dollars in respect of any motor vehicle (other than a motor cycle) imported into the Islands;
- (b) a special waste handling fee of seventy-five dollars in respect of any motor cycle imported into the Islands;
- (c) a special waste handling fee of five dollars in respect of any lead-acid battery imported into the Islands; and
- (d) a special waste handling fee of two dollars in respect of any motor vehicle tyre imported into the Islands.
- (2) For the purposes of this section -

"Customs" means the Department of Customs established under section 3 of the Customs Law (1998 Revision) and includes any officer authorised to act on its behalf.".

Insertion of section 70 fees for miscellaneous services 5. The principal Law is amended in Part XV by inserting, after section 69, the following section -

"Fees for miscellaneous services

70. Without prejudice to any other provision of this Law, the Governor may make regulations prescribing fees, tariffs or charges for any service provided under this Law.".

Validation

- 6. (1) The charging and collection of fees prior to the date of commencement of this Law, in purported exercise of powers conferred by the principal Law, is validated and is to be taken to have been lawfully charged and collected.
- (2) This Law does not affect any order or determination made by a court before the coming into force of this Law.
- (3) If any proceeding for an offence committed before the coming into force of this Law was commenced, but not finally determined, before that time,

or is commenced on or after that time, the proceeding is to be dealt with and determined as if this Law had not been enacted.
