COMPANIES MANAGEMENT (EXEMPTION) REGULATIONS

(1998 Revision)

1. These regulations may be cited as the Companies Management (Exemption) Regulations (1998 Revision).

2. The persons named in the First Schedule are exempt from the provisions of sections 4 and 7(1) of the Companies Management Law (1997 Revision), hereinafter called "the Law", subject to the conditions appearing opposite their respective names in the said Schedule.
