THE ROAD LAW (LAW 18 OF 1974) DECLARATION (SECTION 5 (1))

In exercise of the powers conferred upon the Governor in Council by sub-section (1) of Section 5 of the above Law, it is hereby declared that:-

- 1. It is the intention of Government to construct a new road over an existing private Right of Way in Block No. 1C Parcel Nos. 72, 67, 170, 185, 186 and Block No. 4B parcel No. 22 in the West Bay North West Registration Section. The width of the new road is to be 30 feet as described in the schedule herewith.
- 2. The portions of land affected by this declaration and their approximate areas lost are as follows:-
