THE PRISONS LAW (LAW 14 OF 1975) PRISONS (AMENDMENT) RULES, 1984

In exercise of the powers conferred on the Director of Prisons, with the approval of the Governor in Council, by section 7 of the Prisons Law, the following Rules are hereby made —

Citation

1. These Rules may be cited as the Prisons (Amendment) Rules, 1984.

Insertion of new reg. 1A.

2. The Prisons Rules, 1981, in these Rules referred to as the principal Rules, are amended by inserting the following new regulation immediately after regulation $1\,$ —

"Definition of "prison". 1A Notwithstanding the definition of "prison" in the Law, in these Rules.

"Prison" shall, where the content so admits, be deemed to include — $\,$

- (a) the precincts of a prison; and
- (b) any place or area outside a prison where there is a work-party.".

Amendment of rule 12.

3. Rule 12 of the principal Rules is amended by substituting "Every" for "A convicted" in the first line of sub-rule (2).

Amendment of rule 13.

- 4. Rule 13 of the principal Rules is amended by substituting "daily" for "regularly" in—
 - (a) the first line of sub-rule (3);
 - (b) the second line of sub-rule (4).
