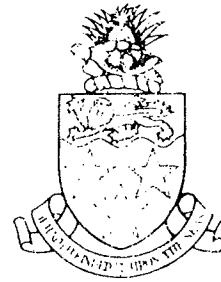

In exercise of the powers conferred on the Governor in Council by section 12 of the Trade and Business Licensing Law (Revised), the following Regulations are hereby made -

1. These Regulations may be cited as the Trade and Business Licensing (Amendment) Regulations, 1985.

2. Regulation 2 of the Trade and Business Licensing Regulations (Revised) is substituted by the following -

2. The following form is prescribed as the form of application for a licence or a renewal thereof -

**APPLICATION FOR THE GRANT OR RENEWAL UNDER SECTION 5 OF THE  
TRADE AND BUSINESS LICENSING LAW (REVISED)**

To be completed in block capitals and forwarded to the secretary of the Caymanian Protection Board, together with the appropriate fee.
