## THE PUBLIC LOANS LAW (LAW 10 OF 1976) THE PUBLIC LOANS (AMENDMENT) REGULATIONS, 1987

In exercise of the powers conferred by section 15 of the Public Loans Law, the following Regulations are hereby made -

Citation and date of Commencement.

- 1. These Regulations may be cited as the Public Loans (Amendment) Regulations, 1984 and shall come into force on the same day a the Public Loans (Amendment) Law, 1984.
- Amendment of Regulation 2.
- 2. Regulation 2 of the Public Loans Regulations, in these Regulations referred to as the principal Regulations, is amended by substituting the following item for the item relating to the definitions of "Bank" "Board" means the Cayman Islands Currency Board;"

Amendment of Regulations.

- 3. The principal Regulations are amended by substituting "Board" for "Bank" in -
  - (a) in the first and second lines of regulation 4;
  - (b) the first and third lines of paragraph (b) of regulation 6;
  - (c) the first line of regulation 7;
  - (d) the first, third and fourth lines of regulation 8;
  - (e) the first line of regulation 10;
  - (f) the third line of regulation 11;
  - (g) the second, third and fifth lines of regulation 12;
  - (h) the second line of regulation 13;
  - (i) the first and third lines of regulation 14.

- 4. The Schedule to the principal Regulations is amended -
