Cayman Brac, from the Airport, map reference 165771, to a point one-eight of a mile west of Faith Hospital, map reference 7052462N 2043118E, and from a point one-eight of a mile east of Faith Hospital, map reference 7153203N 2044207E, to a point one-eight of a mile west of the Cayman Brac High School, map reference 7157090N 2048390E, and from a point one-eight of a mile east of the Cayman Brac High School, map reference 715764N 2049585E, to Taylor Foster's corner, map reference 306845, throughway A7 from the junction of Gerrard Smith Avenue, map reference 7142, to Pollards Bay where the road ends, map reference 325826;

(v) for the Cross Island Bluff Road and the throughway A7, Cayman Brac, from map reference 174776 to Pollards Bay where the road ends, map reference 325826."

## THE TRAFFIC LAW (REVISED) THE TRAFFIC (AMENDMENT) REGULATIONS, 1987

In exercise of the powers conferred on the Governor in Council by section 77 of the Traffic Law (Revised), the following Regulations are hereby made -

1. These Regulations may be cited as the Traffic (Amendment) Regulations, 1987.

Substitution of reg. 20

Citation

2. Regulation 20 of the Traffic Regulations, in these Regulations referred to as the principal Regulations, is substituted by the following -

> "Unsafe loading etc. 20 (1) A motor vehicle, every trailer drawn thereby and all parts and accessories of such vehicle and trailer shall at all times be in such condition, and the number of passengers carried by such vehicle or trailer, the manner in which any passengers are carried in or on such vehicle or trailer, and the weight, distribution, packing and adjustment of the load of such vehicle or trailer shall at all times be such that no danger or nuisance is caused or is likely to be caused to any person.

> (2) The load carried by a motor vehicle or trailer shall at all times be so secured, if necessary by physical restraint other than its own weight, and be in such a position, that neither danger nor nuisance is likely to be caused to any person or property by reason of the load or any part thereof falling or being blown from the vehicle or by reason of any other movement of the load or any part thereof in relation to the vehicle.

> (3) Any person who uses, or causes or permits to be used. on a road a motor vehicle or trailer in contravention of paragraphs (1) and (2) is guilty of an offence and liable on summary conviction to a fine not exceeding two hundred dollars or to imprisonment for a term not exceeding three months or to both such fine and imprisonment."

- 3. Regulation 22 of the principal Regulations is amended by -
  - (a) substituting the following for paragraph (m) of sub-regulation (1) -
    - "(m) for throughway A6, Cayman Brac, from a point one-quarter of a mile west of the West End Primary
