A LAW TO CONFER POWER TO RAISE A LOAN NOT EXCEEDING ONE AND HALF MILLION DOLLARS FOR THE FINANCING OF IMPROVEMENTS TO THE GEORGE TOWN HOSPITAL

ENACTED by the Legislature of the Cayman Islands.

Short Title.

1. This Law may be cited as the Loan (George Town Hospital) Law,

Authority to borrow.

2. The Governor in Council is hereby authorised to borrow, either at one time or by instalments, an amount not exceeding the sum of one and a half million dollars.

Appropriation of borrowing. Schedule.

3. Sums borrowed under the Authority of this Law shall be applied and are hereby appropriated to the various purposes set out in the Schedule.

Terms of borrowing.

4. (1) The borrowing hereby authorised, or any part thereof, may be from such person or persons and upon such terms and subject to such conditions as the Governor in Council may approve.

(2) So soon as is possible after an agreement for the borrowing authorised hereunder, or any part thereof, has been concluded with the lender, the Financial Secretary shall cause a copy to be laid before the Legislative Assembly.

Principal and interest charged on revenue.

5. The principal sum borrowed under Section 2, together with any interest thereon, is hereby charged on and payable out of the general revenues and assets of the Cayman Islands.

SCHEDULE

The construction and equipping of a 12-bed surgical suite;

The conversion of the present Surgical Ward to an Intensive Care Unit; 2.

The provision of a trauma/minor operating room; 3.

The provision of a recovery area; 4.

The conversion of the present recovery area to an ambulatory recovery area; 5.

The necessary works to correct patient flow and other inadequacies in the present 6. operating theatres;

The provision of proper and adequate support service areas for the operating rooms, Surgical Ward and Intensive Care Unit;

The development of a Master Plan for the future use of the present hospital site; 8.

The development of a Master Plan for the Faith Hospital in Cayman Brac; and 9.

The design, equipment specifications and all construction drawing for the additional 18-bed suite for Faith Hospital.

Passed by the Legislative Assembly this 18th day of July, 1990.
