## THE PORT AUTHORITY LAW

## THE PORT (AMENDMENT) REGULATIONS, 1990

In exercise of the powers conferred upon the Governor in Council by section 13(b) of the Port Authority Law, the following Regulations are hereby made -

Citation and Commencement.

1. These Regulations may be cited as the Port (Amendment) Regulations, 1990, and shall come into operation on the 1st day of July, 1990.

Amendment of Reg. 106.

2. Regulations 106 of the Port Regulations (hereinafter called "the principal Regulations") is amended in paragraph (4) thereof by substituting the symbols and figures "\$3.25", "\$1.95" and "\$9.75" for the symbols and figures "\$2.50", "\$1.50" and "\$7.50", respectively, appearing in sub-paragraphs (a), (b) and (c) of the paragraph.

Amendment of Reg. 107 of the principal Regulations.

- 3. Regulation 107 of the principal Regulations is amended  $\,$ 
  - (a) by substituting the symbols and figures "\$13.00", "\$9.10", "\$10.40", "\$6.50", "\$5.20 (in 2 places), and "\$8.45" for the figures "10.00", "7.00", "8.00", "5.00" "4.00 (in 2 places) and "6.50" where they respectively appear in paragraph (1);
  - (b) by substituting the symbols and figures "\$4.55", "\$5.20" (in 2 places), and "\$7.80" for the figures "3.50", "4.00 (in 2 places), and "\$6.00" where they respectively appear in paragraph (2)(a), (b) and (c);
  - (c) by substituting the symbols and figures "\$130.00" and "\$11.70" for the words "one hundred dollars" and the symbol and figure "\$9.00" respectively appearing in sub-paragraphs (a) and (b) of paragraph (3).

Amendment of Reg. 108 of the principal Regulations.

4. Regulation 108 (1) of the principal Regulations is amended by substituting the symbol and figure "\$2.60" for the symbol and figure "\$2.00".

Amendment of Reg. 109 of the principal Regulations.

- 5. Regulation 109 of the principal Regulations is amended as follows -
  - (a) in paragraph (1), for the figures "3.00", "1.50", "3.00" and "2.00" appearing in sub-paragraphs (a), (c) and (d), substitute the symbols and figures "\$3.90", "\$1.95", "\$4.00" and "\$2.60", respectively;
  - (b) replace sub-paragraph (f) by the following -
    - "(f) In addition to any charges payable on cargo under sub-paragraphs (a), (b) or (c), a heavy lift charge of \$26.00 is payable on each container containing such cargo or for a heavy lift involved in handling the same:

PROVIDED that no additional charge shall be payable under this sub-paragraph in respect of the handling by any person other than the Authority with its permission, of any container equipped with wheels and capable of being moved under motive power of its own or derived from another vehicle."

Amendment of Reg. 109A of the principal Regulations.

- 6. Regulation 109A of the principal Regulations is amended -
  - (a) in paragraph (1) by substituting the symbols and figures "\$3.25" and "\$5.85" for the symbols and figures "\$2.50" and "\$4.50";
  - (b) in paragraph (2) by substituting the symbols and figures "\$1.95" and "\$3.25" for the symbols and figures "\$1.50" and "\$2.50".

Amendment of Reg. 109B of the principal Regulations.

7. Regulation 109B is amended by substituting the symbols and figures "\$32.50", "\$84.50" and "\$4.05" for the symbols and figures "\$25", "\$65" and "\$3.10", respectively.

Amendment of Reg. 111 of the principal Regulations.

8. Regulation 111 is amended in paragraph (1) by replacing the symbol and figure "\$5.00" by the symbol and figures "\$6.50".

Amendment of Reg. 114 of the principal Regulations.

9. Regulation 114(4) is amended by the substitution of the symbol and figure "\$325.00" for the symbol and figure "\$250.00" appearing in the provision relating to the "Distribution of Merchandise not otherwise listed...in port".
