THE ROADS (FORMS FOR COMPENSATION) REGULATIONS, 1990

In exercise of the powers conferred upon the Governor in Council by sections 7(4) and 19(i) of the Roads Law (Revised) the following regulations are hereby made -

Citation.

1. These regulations may be cited as the Roads (Forms for Compensation) Regulations, 1990.

Interpretation.

2. In these Regulations "the Law" means the Roads Law (Revised).

Forms. Schedule.

- 3. (1) A notice of intention to claim compensation under section 9(1) of the Law shall be made in Form A in the Schedule.
- (2) A claim for compensation pursuant to section 9(2) shall be made in Form B in the Schedule.
- (3) All forms required to be completed under this regulation shall be filed in the office of the Lands Officer.
