## THE TRADE AND BUSINESS LICENSING (VARIATION) ORDER, 1990

In exercise of the powers conferred upon him by section 13 of the Trade and Business Licensing Law (Revised) the Governor in Council hereby makes the following order --

Citation.

1. This order may be cited as the Trade and Business Licensing (Variation) Order, 1990.

Variation of fees in the Schedule to the Law.

- 2. It is hereby ordered that with effect from the first day of January, 1991, the Schedule to the Trade and Business Licensing Law (Revised) shall be amended as follows --
  - (a) Under the Heading "PROFESSIONAL", substitute --
    - (i) "\$400.00" for "\$300.00" appearing in the third column against items 1, 2, 3, 4, 5 and 8;
    - (ii) "\$3.00", "\$70.00" and "\$3000.00" for "\$2.00", "\$50.00 and "\$2000" where they respectively appear in paragraph (i) of item 6;
    - (iii) "\$260.00" for "\$200" in sub-paragraph (a) of paragraph (ii) of item 6;
    - (iv) "\$13.00", "\$2.60" and "\$9,750.00" for "\$200", "\$2.00" and "\$7,500" where the latter figures respectively appear in
