## THE POSTAL LAW

### THE POSTAL (AMENDMENT) REGULATIONS, 1991

In exercise of the powers conferred upon the Governor by section 24 of the Postal Law the following Regulations are made –

Citation and commencement.

1. These Regulations may be cited as the Postal (Amendment) Regulations, 1991, and shall come into force on the 1st day of June, 1991.

Amendment of Schedule C.

2. Schedule C to the Postal Regulations (hereinafter called "the principal Regulations") is amended –

(a) by replacing the item "LETTERS" and all the provisions relating to that item, by the following –

"LETTERS                      \$0.20 per ounce or part thereof up to a limit of 4 lbs.";

(b) by replacing the item "PRINTED PAPERS" and all the provisions relating to that item by the following –

"PRINTED PAPERS          \$0.10 per ounce or part thereof to a limit of 4 lbs.";

(c) by deleting from the item "LITERATURE FOR THE BLIND" the word "Foreign".

Replacement of Schedule D of the principal Regulations.

3. Schedule D to the principal Regulations is replaced by the following –
