**THE FIREARMS (AMENDMENT) LAW, 1986  
(LAW 19 OF 1986)**



Amendment of s. 40.

16. Section 40 of the principal Law is amended by -
- (a) inserting “Royal” immediately before “Cayman” in the first and in the fourth lines of paragraph (d); and
  - (b) substituting “to” for “of” where that word appears for the last time in the first line of paragraph (f).

**A LAW TO AMEND THE FIREARMS LAW  
(REVISED)**

ENACTED by the Legislature of the Cayman Islands.

Short title.

1. This Law may be cited as the Firearms (Amendment) Law, 1986.

Amendment of s. 4.

2. Section 4 of the Firearms Law (Revised), in this Law referred to as the principal Law, is amended by -

- (a) substituting “(4)” for “(2)” at the beginning of the penultimate line and by deleting “Law 14 of 1971.” from the margin of that line; and
- (b) substituting “(Second Revision)” for “,1971” in the last line.

Amendment of s.10.

3. Section 10 of the principal Law is amended by -

- (a) inserting “or alter” immediately after “repair” in the first line of subsection (1); and
- (b) substituting “three hundred dollars” for “\$100” in the second line of subsection (2).

Amendment of s. 11.

4. Section 11 of the principal Law is amended by substituting the following for paragraph (b) of subsection (1) -

“(b) unless the person who delivers it produces a valid Firearm User’s Licence issued to him in relation to that firearm.”.

Amendment of s. 12.

5. Section 12 of the principal Law is amended, in subsection (3), by substituting -

- (a) "five hundred dollars" for "\$100" in the second line; and
- (b) "twelve" for "six" in the last line.

Amendment of s. 13.

6. Section 13 of the principal Law is amended by substituting -

- (a) "principal" for "princiupal" in the second line of subsection (1);
- (b) "carries" for "carried" in the third line of subsection (1);
- (c) "licensee" for "licence" in the fourth line of subsection (1);
- (d) " "Licensed as a gunsmith to repair and alter firearms" followed by the type of firearm that the licensee has been licensed to repair and alter" for " "Licensed as a Gunsmith" " in the last line of subsection (1);
- (e) "two hundred dollars" for "\$30" in the second line of subsection (2); and
- (f) "six" for "three" in the last line of subsection (2).

Amendment of s. 14.

7. Section 14 of the principal Law is amended by substituting "two hundred dollars" for "\$100" in the second line of subsection (3).

Amendment of s. 16.

8. Section 16 of the principal Law is amended, in subsection (3), by substituting -

- (a) "five hundred dollars" for "\$20" in the second line; and
- (b) "twelve months" for "thirty days" in the last line.

Amendment of s. 18.

9. Section 18 of the principal Law is amended by substituting "three hundred dollars" for "\$100" in the second line of subsection (3).

Amendment of s. 19.

10. Section 19 of the principal Law is amended by inserting "and altering such type of firearms as are specified therein" immediately after "repairing" in the second line of paragraph (c).

Amendment of s. 27.

11. Section 27 of the principal Law is amended by substituting -

- (a) "by" for "be" in the second line of paragraph (b) of subsection (2);
- (b) "two hundred dollars" for "\$20" in the penultimate line of subsection (3); and
- (c) "six months" for "thirty days" in the last line of subsection (3).

Amendment of s. 28.

12. Section 28 of the principal Law is amended by -

- (a) Substituting "notice; and" for "licence." at the end of paragraph (b) of subsection (3) and by adding the following

new paragraph immediately thereafter -

"(c) requiring such person to deliver to him forthwith the firearm to which such licence or permit relates.";

- (b) inserting "or on being required so to do under paragraph (c) of subsection (3) fails to deliver forthwith such firearm" immediately after "notice" in the third line of subsection (4);
- (c) substituting "five hundred dollars" for "\$20" in the penultimate line of subsection (4);
- (d) substituting "six months" for "thirty days" in the last line of subsection (4); and
- (e) adding the following new subsection -

"(5) Every firearm received by the appropriate authority under paragraph (c) of subsection (3) shall -

- (a) on the production by any person of a Firearm User's Licence granted to him in relation to such firearm either before or after the date on which such firearm was received, be delivered to such person; or
- (b) if not so delivered within twelve months of the date on which it was received, be forfeited to the Crown."

Amendment of s. 32.

13. Section 32 of the principal Law is amended, in subsection (2), by substituting -

- (a) "five hundred dollars" for "\$20" in the penultimate line; and
- (b) "twelve months" for "thirty days" in the last line.

Amendment of s. 33.

14. Section 33 of the principal Law is amended, in subsection (3), by substituting -

- (a) "two hundred dollars" for "\$20" in the penultimate line; and
- (b) "six months" for "thirty days" in the last line.

Amendment of s. 36.

15. Section 36 of the principal Law is amended, in subsection (3), by substituting -

- (a) "five hundred dollars" for "\$20" in the second line; and
- (b) "twelve months" for "one month" in the last line.
