THE FIREARMS LAW (REVISED) THE FIREARMS (AMENDMENT) REGULATIONS, 1990

In exercise of the powers conferred upon the Governor by section 39 of the Firearms Law (Revised), the following Regulations are made -

Citation and commencement.

1. These Regulations may be cited as the Firearms (Amendment) Regulations, 1990, and shall come into force on the date on which the Firearms (Amendment) Law, 1990, takes effect.

Amendment of reg. 2 of the Firearms Regulations, 1976.

2. Regulation 2 of the Firearms Regulations, 1976, (hereinafter called "the principal Regulations") is amended in paragraph (a) by deleting the words and parentheses "User's (General) Licences".

Amendment of reg. 3 of the principal Regulations.

3. Regulation 3 of the principal Regulations is amended by -

First Schedule.

- (a) replacing the word "Schedule" in paragraph (a) thereof by the words "FIRST SCHEDULE";
- (b) replacing the full-stop at the end of paragraph (b) by a comma;
- (c) adding the following at the end of the regulation -

"and shall be accompanied by the appropriate fee as set out in the Second Schedule.".

Second Schedule.

Amendment of reg. 5 of the principal Regulations.

- 4. Regulation 5 of the principal Regulations is amended by -
 - (a) deleting paragraph (i);
 - (b) re-numbering paragraphs (ii) and (iii) as paragraphs (i) and (ii), respectively.

Amendment of reg. 6 of the principal Regulations.

Amendment of items listed under heading of "Descriptions....", etc.

- 5. Regulation 6 of the principal Regulations is amended by substituting "\$10.00" for "\$2.00" in the second line thereof.
- 6. The principal Regulations are amended by replacing the heading "Descriptions of Permits. Licences Available" and all the items described under that heading by the following as regulation 7 -

Schedule.

"7. The several permits and licences issuable under the Law are those set out in section 19 of the Law, and for which the fees specified in the Second Schedule are payable.".

Replacement of the Schedule to the principal Regulations. 7. The Schedule to the principal Regulations is replaced by the following -

 - (d) that any licence issued to me must be renewed according to the provisions of the Firearms Law.
