- (b) by inserting the following new Item after Item 2-  
"2A. Proof of Nationality \$50";
- (c) in Item 3, by repealing the words "\$10" and substituting the words "\$50";
- (d) by repealing Item 4 and substituting the following Item-
  - (a) Tax undertaking granted to an exempted company under section 6 of the Tax Concessions Law (1999 Revision), a tax undertaking granted to an exempted trust under section 81 of the Trusts Law (2001 Revision) and a tax undertaking granted to an exempted limited partnership under section 17 of the Exempted Limited Partnership Law (2001 Revision) (including duplicates and renewals) \$150 per undertaking, duplicate or renewal
  - (b) Certified copies of tax undertaking to an exempted company, an exempted trust or an exempted limited partnership \$15 per copy
  - (c) Endorsement of change of name on a tax undertaking to an exempted company, an exempted trust or an exempted limited partnership \$20 per endorsement.";
- (e) in Item 7, by repealing paragraph (b); and
- (f) in Item 8, by repealing the words "\$10" and substituting the words "\$25".

**A LAW TO AMEND THE GOVERNMENT FEES LAWS TO INCREASE  
CERTAIN FEES; AND FOR INCIDENTAL AND CONNECTED  
PURPOSES**

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Government Fees (Amendment) (Increased Fees) Law, 2001. Short title
