THE HEALTH SERVICES LAW (Law 20 of 1974)

THE HEALTH SERVICES (FEES) REGULATIONS, 1975

In exercise of the powers conferred upon the Governor in Council by section 7 of the Health Services Law, the following Regulations are hereby made:—

Short title and commencement.

1. These Regulations may be cited as the Health Services (Fees) Regulations, 1975, and shall come into operation on the 1st day of January, 1976.

Interpretation.

2. In these Regulations —

"Department" means the Health Services Department established under subsection (1) of section 4 of the Health Services Law;

"private duty nurse" means a nurse on the nursing staff of the Department whose services have been made available on an overtime basis to an in-patient.

Fees payable for treatment, etc.

3. The fees specified in the Schedule shall be payable in respect of any treatment, accommodation, amenities, facilities, services or materials provided by or through the Department.

Residents of Lesser Islands to pay half.

4. Persons ordinarily resident in the Lesser Islands who receive treatment or materials at the Cayman Brac Faith Hospital shall be liable to pay only one-half of the fees specified in the Schedule.

School children

5. All out-patient services and prescriptions for children up to school leaving age shall be free of charge, except for consultation by appointment.

Ante-natal services free.

6. All ante-natal services including clinics, blood-testing and drugs necessitated by pregnancy shall be free of charge.

indigent persons free.

7. The fees payable for services and prescriptions received by indigent persons shall be waived, in whole or in part, upon the presentation of a certificate to that effect signed by or on behalf of the Principal Secretary in charge of Social Services.

Non-residents liable to 50 p.c. surcharge.

8. A patient who is not ordinarily resident within the Islands will be required to pay a surcharge of 50 p.c. of the particular fee or fees in the Schedule applicable to that patient.

Fees to be accounted for. 9. All fees payable by virtue of these Regulations shall be paid to the Department and shall be accounted for to the Treasury by such officer as the Chief Medical Officer shall appoint.
