THE IMMIGRATION (AMENDMENT) (NO. 2) REGULATIONS, 2002

The Governor in Council, in exercise of the powers conferred by section 75 of the Immigration Law, makes the following Regulations -

1. These Regulations may be cited as the Immigration (Amendment) (No.2) Regulations, 2002.

Citation
2. The Schedule to the Immigration Regulations (2001 Revision) is amended as follows:

Amendment of Schedule to the Immigration Regulations (2001 Revision)- prescribed fees

(a) by repealing “50” appearing opposite to the item “Application for permanent residence” and substituting therefor “250”;

(b) by repealing the words “35 per application” appearing opposite to the item “Application for the grant or renewal of a work permit” and substituting therefor the words “50 per application”;

(c) in item 1(10) under the heading “Persons employed in Grand Cayman” by repealing the words “10,000 p.a.” and substituting therefor the words “15,000 p.a.”;

(d) in item 1(10) under the heading “Persons employed in Cayman Brac or Little Cayman” , by repealing the words “7,500 p.a.” and substituting therefor the words “11,250 p.a.”;

(e) in the item “Variation of a work permit (Persons employed in Grand Cayman, Cayman Brac or Little Cayman)”, by repealing “35” appearing opposite to the word “Application” and substituting therefor “50”;

(f) by repealing the item “Grant to or renewal by a professional firm of a work permit in respect of any of its partners, directors and associates not having Caymanian status”;

(g) In the item “Application for grant of temporary work permit”, by inserting after the word “grant” the words “or renewal”;

(h) in the item “In respect of residence in the Islands of the dependants of the holder of a work permit” by repealing paragraphs (a) and (b) and substituting therefor the following paragraphs :

“(a) in the case of a work permit holder engaged in domestic or unskilled work
