A LAW TO AMEND THE JUDICATURE LAW (2002 REVISION); AND FOR INCIDENTAL AND CONNECTED PURPOSES

Enacted by the Legislature of the Cayman Islands.

1. (1) This Law may be cited as the Judicature (Amendment) Law, 2003.

Short title and commencement

- (2) This Law shall be deemed to have come into force on 1st July, 2003.
