# THE MARINE CONSERVATION LAW, 1978 (Law 19 of 1978) THE MARINE CONSERVATION (AMENDMENT) REGULATIONS, 1988

In exercise of the powers conferred on the Governor in Council by section 24 of the Marine Conservation Law, 1978, the following Regulations are hereby made -

Citation.

- 1. These Regulations may be cited as the Marine Conservation (Amendment) Regulations, 1988.
- Insertion of new regs. 8 and 9.
- 2. The Marine Conservation Regulations, 1979, are amended by inserting the following two new regulations -

"No diving zones.

- 8. (1) The areas described in the Schedule are designated as no-diving zones.
- (2) Scuba-diving in a no-diving zone is prohibited.

Damage to coral reef.

- 9. (1) Whoever anchors any vessel exceeding twenty feet in length or a commercial vessel, or allows any of such vessels to be anchored, in such a manner that damage is caused to the coral by an anchor, chain or any similar contrivance, is guilty of an offence.
- contrivance, is guilty of an offence.
  (2) In this regulation, "commercial vessel" means a vessel which is for hire for the carriage of passengers or which is carrying passengers as part of a charter or other commercial venture.".
