The Miscellaneous Provisions (Fees and Duties) (Temporary) (Amendment) (Environmental Protection Fees) Law, 1998

- (i) during the period of one year beginning on 1st October, 1997, an environmental protection fee of \$1.60; and
- (ii) after the expiry of the period referred to in subparagraph (i), an environmental protection fee of \$3.20; or
- (b) a year-round cruise ship-
 - (i) during the period of one year beginning on 1st October, 1997, an environmental protection fee of \$0.80; and
 - (ii) after the expiry of the period referred to in subparagraph (i), an environmental protection fee of \$1.60.
- (3) A cruise ship which is not specified in accordance with subsection (2) by the time that it moors or anchors within the Islands' territorial waters shall be deemed to have been specified as a seasonal cruise ship for the purposes of this section.
- (4) The Governor in Council may, by regulations subject to affirmative resolution, prescribe fees for periods after the expiry of 1 year after the periods specified in subsection (2)(a)(i) and (b)(i).
- (5) For the purposes of this section "agent" means the agent to be appointed under subsection (6).
- (6) Every person having a full or part proprietorial interest in a vessel or aircraft in the Islands shall appoint an agent in respect of that vessel or aircraft for the purposes of collecting and accounting for the environmental protection fees referred to in subsection (2)."

A LAW TO AMEND SECTION 7 OF THE MISCELLANEOUS PROVISIONS (FEES AND DUTIES) (TEMPORARY) LAW, 1997 TO PROVIDE FOR THE COLLECTION OF ENVIRONMENTAL PROTECTION FEES; AND FOR INCIDENTAL AND CONNECTED PURPOSES

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Miscellaneous Provisions (Fees and Duties) (Temporary) (Amendment) (Environmental Protection Fees) Law, 1998.

Short title

2. Section 7 of the Miscellaneous Provisions (Fees and Duties) (Temporary) Law, 1997 is repealed and the following section is substituted-

Amendment of Section 7
- Environmental protection fees

- "7. (1) Every agent shall collect from every passenger in every outward bound vessel or aircraft an environmental protection fee of \$2.00 or such other sum as may be prescribed by the Governor in Council in regulations made subject to affirmative resolution.
- (2) Every agent shall collect from every passenger who is on board, when it moors or anchors within the Islands' territorial waters, a ship specified by the Minister for the time being responsible for tourism as-
 - (a) a seasonal cruise ship-
