**A LAW TO AMEND THE INTERPRETATION LAW
AND OTHER LAWS TO PROVIDE FOR THE
PROPER REFERENCE TO THE CORRECT NAMES OF
THE ISLANDS OF CAYMAN BRAC AND LITTLE CAYMAN**

ENACTED by the Legislature of the Cayman Islands.

Short Title.

1. This Law may be cited as the Miscellaneous Laws (Amendment) Law 1990.

Amendment of the
Interpretation Law.

2. The Interpretation Law is amended by inserting the following as sub-section (3) of section 2 -

"(3) It is hereby declared that the Cayman Islands are comprised of Grand Cayman, Cayman Brac and Little Cayman; and any reference in any Law, enactment or other instrument of a public nature to the Islands or any of them shall be a reference to them or it by name, and by no other designation."

3. The Development and Planning Law (Revised) is amended as follows -

- (a) in section 2(1) by -
- (i) inserting in its appropriate alphabetical place the definition ""Appeals Tribunal" means the Appeals Tribunal established under section 39(1).";
 - (ii) deleting the definition of "Lesser Islands Appeal Tribunal";
- (b) in subsection (4) of section 3, for the words "Lesser Islands" substitute the words "Islands of Cayman Brac and Little Cayman";
- (c) in section 8(2)(b), for the words "the Lesser Islands" substitute the words "Cayman Brac or Little Cayman";
- (d) in section 10(1), substitute "Cayman Brac or Little Cayman" for "the Lesser Islands";
- (e) in section 11(1), substitute "Cayman Brac and Little Cayman" for "the Lesser Islands";
- (f) in section 21, delete the letter "s" from the word "notices" in the eighth line;
- (g) in section 23, substitute "in Cayman Brac and Little Cayman" for the words "of the Lesser Islands";
- (h) in section 31, for the figures "19" in the third line, substitute "21 of that Law";
- (i) in section 39 -
- (i) for the words "a Lesser Islands Appeal Tribunal" in the first and second lines of subsection (1), substitute "for Cayman Brac and Little Cayman an Appeals Tribunal";
 - (ii) substitute "Cayman Brac or Little Cayman" for "one of the Lesser Islands" in the fifth line of subsection (1);
 - (iii) delete "Lesser Islands Appeal" and substitute the word "Appeals" in subsections (2) and (3);
- (j) in section 41 -
- (i) delete the words "Lesser Islands Appeal" in the third and fourth lines of subsection (1) and substitute the word "Appeals" in each case;
 - (ii) delete "Lesser Islands" in subsections (2) and (3).

4. The Education Law 1983 is amended as follows -

- (a) delete "Lesser Islands" from the definition of "Board" in section 2;
- (b) delete the words "a Lesser Islands" in the first line of section 5, and substitute the word "an";
- (c) delete "LESSER ISLANDS" from the sub-heading of the Second Schedule and substitute the word "THE".

5. The Elections Law 1983 is amended by deleting the parentheses and words "(LESSER ISLANDS)" from the First Schedule.

6. Section 30 of the Firearms Law (Revised) is amended by deleting the words "Lesser Islands" where they appear in subsections (2), (3) and (4) and substituting the words "Cayman Brac and Little Cayman".

7. Section 2(1) of the Water Authority Law 1982 is amended by deleting therefrom the definition of "Lesser Islands".

8. Section 2(1) of the Tax Collection Law (Revised) is amended by -

- (a) substituting "one" for "each" in the second line;
- (b) deleting "the Lesser Islands" and substituting "another for Cayman Brac and Little Cayman" also in the second line.
