"(2) For the removal of doubt it is hereby declared that where a person is convicted of an offence on trial upon indictment pursuant to subsection (1) the Grand Court may impose a term of imprisonment and a fine in accordance with the provisions of Part B of the Second Schedule."

Amendment of Second Schedule

- 5. The Second Schedule to the principal Law is amended by -
  - (a) inserting the following new paragraph immediately after paragraph (vii) of Part A -

"(viia) Possessing with intent to supply;";

- (b) deleting the words "or offering to do, causing, procuring, soliciting, enticing, aiding, abetting, permitting or suffering any person to do" in paragraph (viii) of Part A, and substituting the words "assisting or being concerned in":
- (c) adding "a" inside the brackets and immediately after "vii" where it occurs in paragraph (viii) of Part A;
- (d) /inserting "Possessing with intent to supply" immediately below "Administering" where it appears in the seventeenth and in the thirtieth lines of the column headed "OFFENCE" in Part B;
- (e) inserting "Assisting or being concerned in" immediately below "Attempting" where it appears in the fourth, eighth, twenty-first and in the last lines of the column headed "OFFENCE" in Part B.

## A LAW TO AMEND THE MISUSE OF DRUGS LAW (SECOND REVISION)

ENACTED by the Legislature of the Cayman Islands.

Short title.

1. This Law may be cited as the Misuse of Drugs (Amendment) Law, 1986.

Amendment of s.2.

2. Section 2 of the Misuse of Drugs Law (Second Revision), in this Law referred to as the principal Law, is amended by deleting the semi-colon at the end of paragraph (b) of the definition of "hard drug" and substituting a comma and by adding onto that definition after paragraph (b) on a new line, the following -

"for the removal of doubt it is hereby declared that for the purposes of this definition the substances listed in paragraph (a) include any of their derivatives as referred to in paragraphs 2, 3 and 4 of the First Schedule;".

Amendment of s.13.

- 3. Section 13 of the principal Law, is amended by -
  - (a) deleting "and" in the third line of subsection (4);
  - (b) inserting the following new paragraph after paragraph (a) in subsection (4) -

"(aa) is specified in Part B of the Second Schedule; and".

Amendment of s.26.

- 4. Section 26 of the principal Law is amended by -
  - (a) inserting "(1)" immediately before "Notwithstanding" in the first line;
