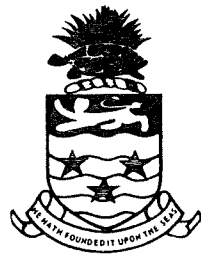

| Short title. | 1. This Law may be cited as the Airports Regulation Law (Revised). |
| Interpretation. | 2. In this Law the expression "airport" means any area of land or water or of land and water designated an airport by regulations made under section 3; and in paragraph (g) of that section the expression "Law" includes any regulations or other instrument made under a Law. |
| Regulations. | <p>3. The Governor in Council may make regulations for the designation, management, control and supervision of airports or of any individual airport and (without prejudice to the generality of the foregoing words) may by such regulations provide —</p> <ul style="list-style-type: none">(a) for designating any area an airport;(b) for prohibiting or regulating in relation to any part of an airport —<ul style="list-style-type: none">(i) the admission of persons whether as passengers or otherwise and of animals; and(ii) the use of aircraft, motor vehicles or vessels of any class or description;(c) for prohibiting or regulating traffic on the roadways in any part of an airport;(d) for regulating the conduct of persons in an airport or in any part thereof;(e) for appointing and regulating the use of parking places for motor vehicles at an airport;(f) for prescribing and regulating the payment and collection of fees for or in relation to services rendered or facilities provided at an airport;(g) for applying whether with or without modification (including addition, omission or amendment) in relation to any roadway in any part of an airport any Law for the time being in force in the Islands with respect to —<ul style="list-style-type: none">(i) the use of public roads by motor vehicles;(ii) motor vehicles using public roads;(h) for any other matter appearing to the Governor to be necessary or expedient for the purpose of giving due effect to the provisions of this Law. |
| Suspected persons. | 4. Any person suspected of having contravened or of being about to contravene any of the regulations made under this Law shall upon being requested so to do by a constable or any other person authorized in that behalf in writing by the |

Governor correctly state his name and address and the purpose of his being at the airport, and upon his failure so to do, and without prejudice to the provisions of section 5, may be removed from the airport or any part thereof by such constable or authorized person, as the case may be.

Penalty.

5. Any persons found contravening any regulation made under this Law may be removed from the area to which the regulation applies by a constable or by any person authorized in that behalf in writing by the Governor, and any vehicle, animal or thing found in the area in contravention of any such regulation may be removed by any constable or person as aforesaid, and upon summary conviction for such contravention, the owner or person in charge of such vehicle, animal or thing may, in addition to such other penalty as may be imposed by the regulations, be ordered by the court to pay the cost of such removal.
