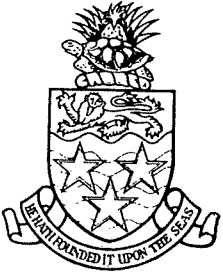

**A LAW TO APPROPRIATE
CERTAIN EXPENDITURES FOR
THE SERVICES OF THE FINANCIAL YEAR 1995**

ENACTED by the Legislature of the Cayman Islands.

Short title.

1. This Law may be cited as the Appropriation (1995) Law, 1994.

Expenditure of
\$162,709,835.

2. The Financial Secretary of the Islands may pay a sum not exceeding \$162,709,835 for defraying the charges and expenses of the Government of the Islands and for other purposes for the financial year 1995 as set forth in the Schedule and such sum is by this Law charged upon the revenue and funds of the Islands.
