# A LAW TO APPROPRIATE EXPENDITURE TO VARIOUS GOVERNMENT SERVICES FOR THE FINANCIAL YEAR 2002

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Appropriation (2002) Law, 2001.

Short title

2. The Financial Secretary of the Islands may pay a sum not exceeding \$293,106,101 for defraying the charges and expenses of the Government of the Islands and for other purposes for the financial year 2002 as set forth in the Schedule and such sum is by this Law charged upon the revenue and funds of the Islands.
