#### A LAW TO APPROPRIATE CERTAIN EXPENDITURES FOR THE SIX-MONTH PERIOD ENDING 30 JUNE 2003

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Appropriation (January to June 2003) Law, 2002.

Short title

2. The Financial Secretary of the Islands may pay a sum not exceeding \$146,060,097 for defraying the charges and expenses of the Government of the Islands and for other purposes for the six month period ending 30 June 2003 as set forth in the Schedule and such sum is by this Law charged upon the revenue and funds of the Islands.
