A LAW TO APPROPRIATE EXECUTIVE FINANCIAL TRANSACTIONS FOR THE FINANCIAL YEAR ENDING 30 JUNE 2005

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Appropriation (July 2004 to June 2005) Law, 2004. Short title
