#### A LAW TO APPROPRIATE EXECUTIVE FINANCIAL TRANSACTIONS FOR THE 18-MONTH PERIOD ENDING 31 DECEMBER, 2017

ENACTED by the Legislature of the Cayman Islands.

1. This Law may be cited as the Appropriation (July 2016 to December 2017) Law, 2016.

Short title

2. The Cabinet may incur executive expenses, acquire executive assets, make equity investments or loans and undertake borrowing for the 18-month period ending 31 December, 2017 in the amount and for the respective purposes set forth in the Schedule.
