THE STATISTICS LAW, 1970 (LAW 2 OF 1970) THE CENSUS (CAYMAN BRAC) REGULATIONS, 1987

In exercise of the powers conferred on the Governor in Council by section 6 of the Statistics Law, 1970, the following Regulations are hereby made -

Citation

1. These Regulations may be cited as the Census (Cayman Brac) Regulations, 1987.

Interpretation.

2. In these Regulations, unless the context otherwise requires, -

"census day" has the meaning assigned to it in paragraph 2 of the Order;

"census forms" means forms issued by the Statistician;

"census information" means particulars required under the Order to be stated in the census returns;

"census night" has the meaning assigned to it in paragraph 2 of the Order:

"enumerator" means a person appointed under regulation 5; "head of household" has the meaning assigned to it in paragraph 2 of the Order;

"Order" means the Census (Cayman Brac) Order, 1987; "supervisor" means person appointed under regulation 4 to be supervisor of the census.

Division into enumeration listricts 3. The Statistician shall divide Cayman Brac into enumeration districts and shall prepare a written description of every such enumeration district.

Annointment of supervisor

4. The Statistician shall appoint a person to be supervisor of the census.

Appointment of enumerators.

5. The Statistician shall appoint such number of persons as may be necessary to be enumerators and shall assign each enumerator to one or more enumeration districts.

Duties of supervisor.

- 6. It shall be the duty of the supervisor to -
 - (a) give all necessary instructions to enumerators;
 - (b) issue to enumerators all census forms and other articles necessary for the taking of the census;
 - (c) examine all entries made in census forms by enumerators and, where it appears upon examination that any census information in any form is defective or omitted, to require the appropriate enumerator to take steps to correct the defective information or to supply the omitted information;
 - (d) make arrangements to replace any enumerator who may be unable to carry out his duties;
 - (e) receive, examine and transmit to the Statistician all census forms delivered to him by enumerators;
 - (f) carry out any instructions issued to him by the Statistician for the purpose of taking the census.

Duties of enumerators.

- 7. It shall be the duty of the enumerator -
 - (a) to meet the supervisor at such times and places as the supervisor may direct;
 - (b) to preserve carefully all written instructions, forms, census forms and other articles issued to him by the supervisor and to return them to the supervisor when call upon to do so;
 - (c) to visit personally every inhabited or habitable dwelling or other premises in the enumeration district or districts to which he may be assigned to deliver and collect census forms and to ensure that they are correctly and fully completed by the head of household, giving any such assistance as may be needed;
 - (d) to make further visits to such dwelling or other premises if on a first visit thereto the required information cannot be obtained and at the direction of the supervisor to re-visit any such dwelling or other premises for the purpose of remedying omissions or correcting or verifying entries in any census form;

to carry out such instructions of the supervisor as may be issued for the purpose of taking census.

Duty to give information to enumerator with respect to oneself.

8. Every person with respect to whom census information is required to be furnished by the Order shall upon demand by an enumerator give to the enumerator such information with respect to himself.

Duty to give information with respect to other

9. (a) The head of household in every private dwelling shall furnish census information with respect to all persons who passed census night in that dwelling or who are usually resident in that dwelling.

(b) The person in charge of every hotel and boarding-house shall furnish census information in respect of all members of his household and all employees and other persons usually resident on the premises who are so resident on census night.

(c) The person in charge of any hospital or rest-home shall furnish census information in respect of persons accommodated therein on census night.

Duty to give information to prescribed persons.

10. Every person with respect to whom it is the duty of the head of household or person in charge, as the case may be, under regulation 9 to furnish census information shall upon demand give such census information to such head of household, proprietor or manager.
