A LAW TO AMEND THE CHILDREN LAW, 2003; AND FOR INCIDENTAL AND CONNECTED PURPOSES

ENACTED by the Legislature of the Cayman Islands.

1. (1) This Law may be cited as the Children (Amendment) Law, 2003.

Short title and commencement

Amendment of section

21 of the Children Law,

2003- review of provision for day care,

child minding etc.

- (2) This Law comes into force immediately after the Children Law, 2003 comes into force.
- 2. The Children Law, 2003, in this Law referred to as "the principal Law" is amended in section 21 as follows-
 - (a) in subsection (1) (b) and (c), by repealing the words "under the age of 8"; and
 - (b) in subsection (3) (a), by repealing the words "under the age of 8".
- 3. The principal Law is amended in section 72 as follows-
- Amendment of section 72 registration
- (a) in subsection (1) (b), by repealing the words "under the age of 8";
- (b) in subsection (2) (a) (i), by repealing the words "under the age of 8";
- (c) in subsection (3), by repealing the words "under the age of 8";
- (d) by repealing subsection (5) and substituting the following-
 - "(5) Subject to subsection (13), a person who is employed to look after a child wholly or mainly in the home of the person

so employing him shall be considered to be a nanny and as such shall not be required to be registered under this Law."; and

(e) in subsections (7), (8), (9), (10) and (11), by repealing the words "under the age of 8";

Amendment of section 77- inspection

4. The principal Law is amended in section 77 (1) (b) by repealing the words "under the age of 8".

Amendment of section 79- offences

5. The principal Law is amended in section 79 (1) by repealing the words "under the age of 8".

Amendment of Schedule 9- child minding and day care for young children

6. The principal Law is amended in Schedule 9 paragraph 1 (2) by repealing the words "under the age of 8".
