# THE CINEMATOGRAPH LAW (1995 REVISION)

## THE CINEMATOGRAPH (AMENDMENT) RULES, 2002

In exercise of the powers conferred by section 8 of the Cinematograph Law (1995 Revision), the Authority with the advice and consent of the Legislative Assembly makes the following rules -

1. These rules may be cited as the Cinematograph (Amendment) Rules, 2002.

Citation

2. The Cinematograph Rules (1995 Revision) are amended by repealing rule 4 and substituting the following rule -

Repeal and substitution of rule 4 of the Cinematograph Rules (1995 Revision) licences

"Licences

- 4. (1) Such licence shall be granted to conduct -
  - (a) cinematographic exhibitions on weekdays;and
  - (b) cinematographic exhibitions on Sundays, in relation to films which have been designated by the British or American Film Censorship Authorities as suitable for viewing by children aged sixteen years and under.
- (2) Licences to conduct cinematographic exhibitions on Good Fridays shall be granted only by special permission of the Authority.".
- 3. The Cinematograph Rules (1995 Revision) are amended in rule 5 by repealing the words "during weekdays".

Amendment of rule 5 of the Cinematograph Rules (1995 Revision) – display of licence Transitional provisions

- 4. A licence which is in force immediately before the date of commencement of these rules shall, on and after that date -
  - (a) continue in force on the same terms and conditions that applied immediately before that date; and
  - (b) be deemed to be subject to an additional condition that cinematographic exhibitions may be conducted on Sundays if the film to be exhibited has been designated by the British or
