ENACTED by the Legislature of the Cayman Islands

**THE COMPANIES (AMENDMENT)  
LAW, 1981  
(LAW 21 OF 1981)**

- (a) "3400" for "3409" in the third line of paragraph (b);
- (b) "3400" for "3430" in the first line of paragraph (b),
- of subsection (4).
2. Section 182 of the principal Law is amended by substituting—
  - (a) "3400" for "3200" in the third line of subparagraph (a);
  - (b) "3400" for "375" in the first line of subparagraph (b),in the last paragraph.
3. Section 183 of the principal Law is amended by substituting "3450" for "3750" in the second line.
4. Section 187 of the principal Law is amended by substituting "3475" for "3775" in the second line.
5. Section 189 of the principal Law is amended by substituting—
  - (a) "3600" for "3400" in the last line of subsection (1);
  - (b) "3300" for "3200" in subsection (2).

Amendment of section 195

1. This Law may be cited as the Companies (Amendment) Law, 1981 and shall come into force on the 1st day of January, 1982.
2. Section 25 of the Companies Law, in this Law referred to as the principal Law, is amended by substituting -
  - (a) "\$500" for "\$400" in the third line of paragraph (i);
  - (b) "\$200" for "\$150" in the first line of paragraph (ii),of subsection (4).
3. Section 38 of the principal Law is amended by substituting -
  - (a) "\$250" for "\$200" in the third line of subparagraph (a);
  - (b) "\$100" for "\$75" in the first line of subparagraph (b),in the last paragraph.
4. Section 183 of the principal Law is amended by substituting "\$850" for "\$750" in the second line.
5. Section 187 of the principal Law is amended by substituting "\$475" for "\$375" in the second line.
6. Section 195 of the principal Law is amended by substituting -
  - (a) "\$600" for "\$400" in the last line of subsection (1);
  - (b) "\$300" for "\$200" in subsection (2).

7. Section 209 of the principal Law is amended by substituting
- (a) "\$7" for "\$3" in paragraph (a);
  - (b) "\$10" for "\$3" in paragraph (b);
  - (c) "\$10" for "\$5" in paragraph (c),
- of subsection (1).
