

IN exercise of the powers conferred on the Governor in Council by section 17 of the Companies Management Law, 1984, the following Regulations are hereby made -

Citation.

1. These Regulations may be cited as the Companies Management (Forms) Regulations, 1985.

Form of application.

2. An application for a licence under subsections (2) or (3) of section 4 shall be made in the form set out in the First Schedule.

Form of licence.

3. A licence granted under subsection (5) of section 4 shall be in the form set out in the Second Schedule.


