In exercise of the powers conferred by section 34 of the Public Health Act (2021 Revision), the Cabinet makes the following Regulations —

Citation and commencement

- 1. (1) These Regulations may be cited as the Control of Covid-19 (Travel) (Amendment) (No. 2) Regulations, 2022.
 - (2) These Regulations come into force on 18th February, 2022.

Amendment of regulation 3 of the Control of Covid-19 (Travel) Regulations, 2022 - restrictions on arrival of unvaccinated persons to the Islands

- **2**. The *Control of Covid-19 (Travel) Regulations*, 2022, in these Regulations referred to as the "principal Regulations", are amended in regulation 3 as follows
 - (a) in paragraph 5(a), by deleting the words "ten days" and substituting the words "seven days";
 - (b) in paragraph 7(b), by deleting the words "ten days" and substituting the words "seven days";
 - (c) in paragraph 9(i), by deleting the words "ten days" and substituting the words "seven days"; and

(d) in paragraph 10(b), by deleting the words "ten days" and substituting the words "seven days".

Amendment of regulation 5 - restrictions on arrival of a person whose vaccination certificate cannot be securely verified

3. The principal Regulations are amended in regulation 5(6) by deleting the words "ten days" wherever they appear and substituting the words "seven days".

Repeal and substitution of regulation 6 - requirement to complete travel declaration and undertake testing

4. The principal Regulations are amended by repealing regulation 6 and substituting the following regulation —

"Requirement to complete travel declaration

6. Where a person under regulation 4(5) intends to travel to the Islands, the person shall, no less than seventy-two hours prior to departing for the Islands, complete and submit a travel declaration in the manner and form specified on the official website of Travel Cayman.".

Amendment of regulation 7 - person to provide evidence of completion of travel declaration

- **5**. The principal Regulations are amended in regulation 7 as follows
 - (a) in paragraph (1), by deleting the words "regulation 6(1)" and substituting the words "regulation 6"; and
 - (b) in paragraph (3), by deleting the words "regulation 6(1)" and substituting the words "regulation 6".

Amendment of regulation 9 - liability of owner of ship or aircraft for persons without proper travel documents

6. The principal Regulations are amended in regulation 9(1)(b) by deleting the words "regulation 6(1)" and substituting the words "regulation 6".



Amendment of Schedule 3 - ticket offences and fines

- **7**. The principal Regulations are amended in Schedule 3 as follows
 - (a) in item 5, by deleting the words "regulation 6(1)" and substituting the words "regulation 6"; and
 - (b) by deleting item 7.
