1. The Traffic (Public Passenger Vehicles) Regulations (2014 Revision)

The Traffic (Public Passenger Vehicles) Regulations (2014 Revision) was published as Supplement No. 15 with Extraordinary Gazette No. 75 dated 10th October, 2014.

On pages 1 and 2 of the publication the chronology of amendments should be deleted and substituted as follows-

“The Traffic (Public Passenger Vehicles) Regulations, 2012 made the 29th August, 2012 consolidated with the Traffic (Public Passenger Vehicles) (Amendment) Regulations, 2013 made the 7th May, 2013 and the Traffic (Public Passenger Vehicles) (Amendment) (No. 2) Regulations, 2013 made the 24th September, 2013.”

2. The Penal Code (2013 Revision)

The following Note, to be inserted immediately after the said paragraph 3(2)(a), is intended to address that omission-

“Note: In relation to any employment agreement, paragraph 3(2)(a) shall expire on 30th June, 2015 and shall be replaced on 1st July, 2015 by the corresponding paragraph 3(2)(a) of the Personnel Regulations that were in force immediately prior to the commencement of the Personnel (Amendment)(No. 2) Regulations, 2012 (i.e. immediately prior to 31st August, 2012).”
