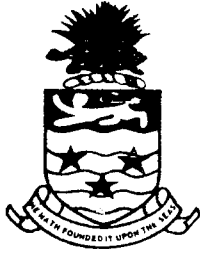

(RECIPROCAL ENFORCEMENT) RULES

In exercise of the powers conferred upon the Rules Committee under the provisions of section 21 of the Grand Court Law, the following Rules of Court are hereby made.

1. These Rules may be cited as the Grand Court (Foreign Judgments) (Reciprocal Enforcement) Rules.
2. An application for registration under a foreign judgment under the Judgments (Foreign) (Reciprocal Enforcement) Law, 1967 —
 - (a) may be made ex-parte by originating summons;
 - (b) shall exhibit an authenticated copy of the judgment with translation into the English language;
 - (c) shall adequately describe the judgment debtor and his place of abode; and
 - (d) shall show that the applicant is entitled to enforce the judgment and the extent to which it remains unsatisfied.
3. The Court may order the applicant to give security for the costs of an application under Rule 2 and matters incidental thereto.
4. The Court may prescribe the method of service of notice upon the judgment debtor of an application under Rule 2 and a period within which application may be made by the judgment debtor to set aside the registration of the judgment, during which period execution of the registered judgment shall be stayed.
5. Forms which may be used under these Rules are prescribed in the schedule.
