**THE IMMIGRATION (AMENDMENT) (NO. 2) REGULATIONS, 2006**

The Governor in Cabinet, in exercise of the powers conferred by section 93 of the Immigration Law, 2003, makes the following regulations -

1. These regulations may be cited as the Immigration (Amendment) (No. 2) Regulations, 2006 and shall come into force on 1<sup>st</sup> July, 2006. Citation and commencement
  
2. The Immigration Regulations, 2004 are amended in the First Schedule under the Heading "**Persons Employed in Grand Cayman**" by deleting the fees payable in respect of the positions listed below in the second column and substituting the following new fees: Amendment of First Schedule to the Immigration Regulations, 2004 – Fees
