THE LIQUOR LICENSING (AMENDMENT) LAW, 1989 (LAW 12 OF 1989)

A LAW TO AMEND THE LIQUOR LICENSING LAW, 1985.

ENACTED by the Legislature of the Cayman Islands.

Short title.

1. This Law may be cited as the Liquor Licensing (Amendment) Law, 1989.

Amendment of section 2 of the principal Law.

2. Section 2 of the Liquor Licensing Law, 1985, in this Law referred to as the principal Law, is amended by inserting the following new definition immediately after the definition of "hotel" -

""Inspector" means the person holding the office of Inspector of Licensed Premises in the public service;".

Amendment of section 10 of the principal Law.

- 3. Section 10 subsection (2) of the principal Law is amended:
 - (a) by deleting paragraph (a) and substituting the following therefor -
 - "(a) A distributor's licence permits the disposal of intoxicating liquor to -
 - (i) other licencees;
 - (ii) persons for export from the Islands:

in sealed containers in quantities of not less than 27.3 litres in the case of beer or 9.1 litres in the case of other intoxicating liquor, for consumption off the premises -

Provided that in the case of disposal for export the distributor shall satisfy himself that the goods are exported by obtaining a copy of a certificate to this effect from the Collector of Customs issued in accordance with section 30 of the Customs Law (Second Revision)."

- (b) in paragraph (b) by addition of the words "; but does not permit disposal to another licensee for the purpose of disposal by him under the terms of his licence" immediately after the word "premises" where it appears in the last line, and before the full stop.
- (c) in paragraph (c) by -
 - (i) inserting the words "in sealed containers, containing beer, of not less than 6.82 litres or, containing any intoxicating liquor other than beer, of not less than .75 litres," immediately after "or" in the last line.
 - (ii) addition of the words ": but does not permit disposal to another licensee for the purpose of disposal by him under the terms of his licence" immediately after the word "premises" where it appears in the last line, and before the full stop.
- (d) in paragraph (d) by -
 - (i) inserting the words "in sealed containers, containing beer, of not less than 6.82 litres or, containing any intoxicating liquor other than beer, of not less than .75 litres," immediately after "or" in the last line.

ii) addition of the words "; but does not permit disposal to another licensee for the purpose of disposal by him under the terms of his licence" immediately after the word "premises" where it appears in the last line, and before the full stop.

Amendment of section 14 of the principal Law.

4. Subsection (2) of section 14 of the principal law is amended by inserting "or in at least one newspaper circulating in the Islands, "immediately after "Gazette" in the second line.

Insertion of new section 30A in the principal Law.

5. The principal Law is amended by inserting the following new section immediately after section 30-

"Powers of Inspector.

30A. (1) The Inspector, on proof (if so required) of his identity, may enter on and inspect any licensed premises in Grand Cayman or any place within the curtilage of such premises at any time when they are open to the public for the sale of intoxicating liquor, for the purpose of detecting any breach of the provisions of this Law or of any licence or authorisation, and shall forthwith report any such breach to the Board for Grand Cayman.

(2) Any person who prevents the entry of, or obstructs the Inspector in the execution of his duty upon any licensed premises or any place within the curtilage thereof shall be guilty of an offence."
