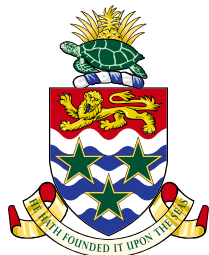

In exercise of the powers conferred by section 50 of the Liquor Licensing Law (2019 Revision) the Cabinet makes the following Regulations —

**Citation**

1. These Regulations may be cited as the Liquor Licensing (Fees) (Amendment) Regulations, 2020.

**Amendment of regulation 2 of the Liquor Licensing (Fees) Regulations (1999 Revision) - prescription of licence fee**

2. The *Liquor Licensing (Fees) Regulations (1999 Revision)*, in these Regulations referred to as the “principal Regulations”, are amended in regulation 2 by deleting the word “subregulation” wherever it appears and substituting the word “paragraph”.

**Insertion of regulation 4 - temporary reduction of fees**

3. The principal Regulations are amended by inserting after regulation 3 the following regulation —

**“Temporary reduction of annual renewal fees**

- 4.** (1) Notwithstanding regulation 2, for the purposes of sections 5(11) and 10(9) of the Law, the fee for an annual renewal of a licence referred to in —
- (a) regulation 2(1); and
  - (b) regulation 2(2) in respect of any distributors, package, hotel or restaurant licence issued in respect of premises situated in Cayman Brac or Little Cayman,
- for the September 2020 annual session shall, subject to paragraph (2), be nil.
- (2) The fee for the September 2021 annual session for the annual renewal of a licence, in respect of an applicant who paid the annual renewal fee for the September 2020 annual session prior to the commencement of the *Liquor Licensing (Fees) (Amendment) Regulations, 2020*, shall be nil.”.

**Expiry**

- 4.** (1) Regulation 4 of the principal Regulations as amended by the *Liquor Licensing (Fees) (Amendment) Regulations, 2020* expires on 30th September, 2021.
- (2) For the avoidance of doubt, the *Liquor Licensing (Fees) Regulations (1999 Revision)* shall, immediately after the expiration of regulation 4 of the principal Regulations as amended by the *Liquor Licensing (Fees) (Amendment) Regulations, 2020*, be read and construed as if these Regulations had not been amended by the *Liquor Licensing (Fees) (Amendment) Regulations, 2020*.
