THE LOCAL COMPANIES [CONTROL] LAW [REVISED] THE LOCAL COMPANIES [CONTROL] [AMENDMENT] REGULATIONS, 1980

In exercise of the powers conferred upon the Governor in Council by section 21 of the Local Companies (Control) Law (Revised), and all other powers him thereunto enabling, the following Regulations are hereby made.

Citation.

1. These Regulations may be cited as the Local Companies (Control) (Amendment) Regulations, 1980.

Amendment to The Local Companies (Control) Regulations. (Revised). 2. The Local Companies (Control) Regulations (Revised) are hereby amended by the addition, immediately following regulation 2 thereof, of the following new regulation —

"Form of return of allotment or transfer of shares. 2A. The form of a return of allotment or transfer of shares in a local company required to be forwarded under section 6(4) is as follows —
