

THE MUTUAL FUNDS LAW THE MUTUAL FUNDS REGULATIONS

In exercise of the powers conferred upon the Governor in Council by section 43 of the Mutual Funds Law, the following regulations are made –

Citation.

1. These regulations may be cited as the Mutual Funds Regulations.

Fees.

2. The prescribed fee for the purpose of a provision of the Law specified in column 2 of the Table of Fees set out in the Schedule is the amount specified in column 4 opposite that provision.
