REGULATIONS, 1986.**

In exercise of the powers conferred on the Governor in Council by section 7 of the Public Service Commission Law (Revised), the following Regulations are hereby made -

Citation and date of commencement.

1. These Regulations may be cited as the Public Service Commission (Amendment) Regulations, 1986 and shall come into force on the 1st day of May, 1986.

Amendment of reg. 2.

2. Regulation 2 of the Public Service Commission Regulations, 1985, in these Regulations referred to as the principal Regulations, is amended by deleting "the Chief Secretary," in the first two lines of the definition of "Principal Secretary" and inserting "the Administrative Secretary".

Amendment of reg. 39.

3. Regulation 39 of the principal Regulations is amended by substituting "the Financial" for "(other than the Financial Secretary) the Chief" in the second and third lines.

Amendment of First Schedule.

4. The First Schedule to the principal Regulations is amended -

- (a) in the item relating to "Administration", by deleting "Chief Secretary;" in column III and by adding "Administrative Secretary;" and "Secretary to the Public Service Commission." to that column;
- (b) in the item relating to "Internal and External Affairs", by substituting "Administrative Secretary" for "Chief Secretary" in column II and by deleting "All Administrative Officers (other than the Financial Secretary)", "Clerk of the Legislative Assembly;" and "Secretary to the the Public Service Commission;" in column III;

- (c) by deleting the item relating to "Legislative Department";
- (d) by deleting the item relating to "Personnel and Office Services";
- (e) by deleting the item relating to "Public Service Commission";
- (f) in the item relating to "Finance and Development Portfolio", by inserting "All Administrative Officers (other than the Administrative Secretary and the Secretary to the Public Service Commission)," "Clerk of the Legislative Assembly," and "Clerk of the Executive Council" immediately after "Superintendent of Insurance;" in column III of that item, and by deleting "administrative officers" from the penultimate line of that column;
- (g) by inserting the following items immediately after the item relating to "Finance and Development Portfolio" -

"Legislative Department	Clerk of the Legislative Assembly	All officers in the Legislative Department of the Portfolio of Internal and External Affairs, other than administrative officers and officers in common user posts.

Personnel and Office Services	Principal Secretary (Personnel)	All officers of the Personnel and Office Services Division of the Portfolio of Internal and External Affairs, other than administrative officers; All officers in common user posts throughout the public service.";

(h) by adding the following item immediately after the item relating to "Audit Department" -

"Public Secretary
Service
Commission

in the office of

Commission."

Amendment of
Principal Regs.

5. Subject to regulations 2, and 4 of these Regulations, the principal Regulations are amended by substituting "Financial Secretary" for "Chief Secretary" wherever it appears.
