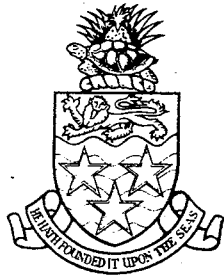

THE PUBLIC SERVICE COMMISSION LAW (REVISED)

THE PUBLIC SERVICE COMMISSION (AMENDMENT) REGULATIONS, 1989

In exercise of the powers conferred on the Governor in Council by section 7 of the Public Service Commission Law (Revised), the following Regulations are hereby made -

- Citation. 1. These Regulations may be cited as the Public Service Commission (Amendment) Regulations, 1989.
- Amendment of reg. 39. 2. Regulation 39 of the Public Service Commission Regulations, in these Regulations referred to as the principal Regulations, is amended by substituting "(other than the Financial Secretary), the Administrative" for ",the Financial" in the second line.
- Amendment of First Schedule. 3. The First Schedule to the principal Regulations is amended -
- (a) in the item relating to "Internal and External Affairs", by inserting "All administrative officers (other than the Financial Secretary and the Secretary to the Public Service Commission):" immediately before "Chief Immigration Officer:" in column III;
 - (b) in the item relating to "Finance and Development Portfolio", by -
 - (i) deleting "All Administrative Officers (other than the Administrative Secretary and the Secretary to the Public Service Commission)," from column III; and
 - (ii) inserting "Chief Marine Surveyor" and "Government Statistician" immediately after "Clerk of Executive Council" in column III of that item.
 - (c) inserting the following items after the item relating to "Finance and Development Portfolio" -

"Marine Survey Department	Chief Marine Surveyor	All officers in the Marine Survey Department other than administrative officers and officers in common user posts.
Statistics Office	Government Statistician	All officers in the Statistics Office other than administrative officers and officers in common user posts."
		(d) in the item relating to "Tourism, Aviation and Trade", by inserting "Director of Trade and Labour:" immediately after "Chief Fire Officer", in column III of that item;
		(e) by inserting the following item immediately after the item relating to "Fire Service Department"-
"Trade and Labour Department	Director of Trade and Labour	All officers in the Trade and Labour Department except officers in common user posts."
		(f) by transferring the item relating to "Personnel and Offices Services" from where it appears beneath the item relating to the "Legislative Department" and inserting it immediately below the item relating to the Immigration Department.
		(g) in the item relating to "Public Service Commission", by transferring "Secretary" from column I to column II and transferring the item "Public Service Commission" to column I.
Amendment of principal Regulations.		4. Subject to regulations 2 and 3 of the principal Regulations, the principal Regulations (other than regulation 2 thereof and the First Schedule thereof) are amended by substituting "Administrative" for "Financial" wherever it appears.
Amendment of Principal Regulations.		5. The Principal Regulations are amended by substituting "Personnel and Management Services" for "Personnel and Office Services" wherever it appears.
